Eligibility Requirements

- The applicant must enroll full-time at a Wisconsin college in the fall 2010 term as either:
 - (1) a second-year student at a technical college; or
 - (2) an upper class (at least third-year) student at a four-year university
- The applicant must be working towards a career in health services. Special consideration will be given to those majoring in nursing, physical therapy, occupational therapy, speech pathology or dental hygiene.
- The applicant or the applicant's spouse, parent, grandparent or guardian must be an employee of a member of WCA Group Health Trust.
