Eligibility Requirements

1. The applicant must enroll full-time at a Wisconsin college in the fall 2010 term as either:
 - (1) a second-year student at a technical college; or
 - (2) an upper class (at least third-year) student at a four-year university
2. The applicant must be working towards a career in health services. Special consideration will be given to those majoring in nursing, physical therapy, occupational therapy, speech pathology or dental hygiene.
3. The applicant or the applicant's spouse, parent, grandparent or guardian must be an employee of a member of WCA Group Health Trust.
